Flight Schedule Policy

Within our standard offering, Cremated Remains will be scheduled for release on the next available flight not to exceed 30 days from receipt at our facility. *"See Weather and Mechanical Disclaimer"*

Special Day Flights may be arranged outside of the standard offering. Whether it be a birthday, anniversary, date of Solo or any other special day, special arrangements can be made to accommodate most request. *"See Weather and Mechanical Disclaimer"*

Weather and Mechanical Disclaimer

In the event of unfavorable weather conditions existing on a designated flight date, the flight will be rescheduled for the next date which meets acceptable flight safety standards. In the event that a flight needs to be rescheduled, the family will be notified on the date of the cancelled flight.

In the event of a mechanical condition occurring on a designated flight date, the flight will be rescheduled for the next date that the aircraft is cleared for flight. In the event that a flight needs to be rescheduled, the family will be notified on the date of the cancelled flight.

Shipping of Cremated Remains to Us

Forever In Flight Aviation, Inc. will take the utmost care and discretion in handling the cremated remains of your loved one until the appointed time for release. To ensure a timely delivery and to avoid complications, we ask that you adhere to these guidelines:

1. PRIOR TO SHIPPING, you must complete and mail this original signed documentation to us at the address below. Cremated remains will not be accepted at our facility without this documentation having been received PRIOR to shipment. Once we have your documentation, we will issue a confirmation number and notify you by e-mail or phone that your information has been received and you are authorized to ship. Please call us with any questions at (352) 206-1103.
 2. Ship the remains only in an approved container and packaging. Your funeral home can assist in getting you the correct materials to ensure a safe shipment.
 3. Once the remains are properly packaged, we recommend the use of the United States Postal Service.
 4. Fill out a Registered Mail Return Receipt Requested form. This is a green and white card offered by the United States Postal Service to request proof of delivery. The card will be mailed to you with the signature of the person who received the remains.
 5. Identify the package as containing cremation remains. This must be noted on the address side of the shipping label, along with the your confirmation number.
 6. Go to the nearest post office and ship the cremated remains either by Express Mail, Priority Mail or Package Services. All three of these options allow you to ship using the Registered Mail Return Receipt Requested feature.
